

Office Memorandum

Subject: Closing of Immigration Check Posts (ICPs) for all incoming passenger traffic.

In continuation of restrictions and advisories including those issued vide orders dated 13th & 14th March, 2020 by MHA and those dated 19th & 21st March, 2020 by BoI, the undersigned is directed to convey the orders of Central Government to stop all incoming passenger traffic on all 107 Immigration Check Posts which includes all Airport ICPs, all Seaport ICPs, all Land Port ICPs, all Rail Port ICPs and all River Port ICPs in view of the spread of COVID-19.

2. Vehicles/ Trains carrying goods for trade or essential goods and supplies are exempted from this prohibition along with their crew, driver, helper, cleaner etc. subject to their thorough screening by medical staff for COVID-19
3. This issues with the approval of the competent authority.

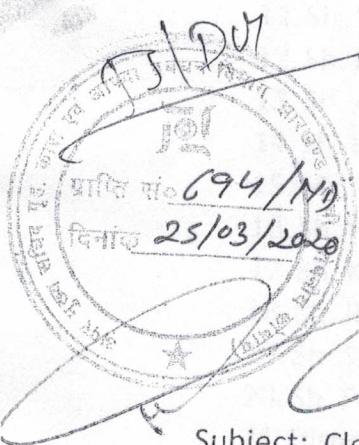
