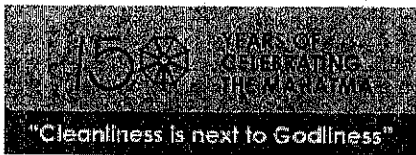

ORDER

Whereas Ministry of Home Affairs Government of India vide no. 40-3/2020-DM-1(A) dated 24th March 2020 issued orders for imposing lockdown in the country till 14th April 2020.

Whereas by order 40-3/2020-DM-I(A) dated 15th April, the Ministry of Home Affairs has extended the lockdown till 3rd May 2020.

Whereas during the lockdown the States were directed by order No. 40-3/2020-DM-I(A) of MHA dated 29th March 2020 to ensure that migrant worker stayed where they were or kept in nearest shelter and States were required to take care of their accommodation food etc.

In supersession of DOP order dated 14.04.2020 and DMRD order no. 5241 dated 26.04.2020 undersigned being the Chairperson of the State Executive Committee appoint Nodal officers for resolving issues of migrant workers of Rajasthan staying in different states of India and migrant workers of other states staying in different districts of Rajasthan.

These officers mentioned in Table below will be Nodal officers for the states against which their name are mentioned: -



This order shall be deemed to have come into force with immediate effect.


