ORDER

MHA in reference 3<sup>rd</sup> cited has issued guidelines for inter-state movement of persons stranded due to lockdown.

2. Nodal Authority, Telangana has consulted his counterpart in Jharkhand. It has been mutually agreed to arrange for transport of 1,176 stranded persons belonging to Jharkhand from Hyderabad to Ranchi by train. Accordingly, the following directions are issued:

- a) Nodal authority, Telangana shall coordinate with his counterpart in Jharkhand for taking action at their end upon arrival of the stranded persons in terms of MHA order at reference 3<sup>rd</sup> cited.
- b) GM, South Central Railway is requested to arrange for special train to Ranchi for the movement of the abovementioned stranded persons.
- c) Director General of Police, Telangana is requested to arrange requisite security arrangements for the movement of the stranded persons to the railway station. Suitable security arrangements shall also be provided at the railway station.
- d) MD, TSRTC shall arrange requisite number of buses at the site where the stranded persons are located for their movement to the railway station.
- e) Collector & District Magistrate, Sangareddy shall arrange for medical screening of the stranded persons for determining their ability to undertake the journey. Further, he shall be responsible for the overall
