



**ORDER**

**Whereas**, in exercise of the powers conferred under section 10(2) (l) of the Disaster Management Act 2005, Union Home Secretary, in his capacity as Chairperson, National Executive Committee, has issued directions vide Order no. 40-3/2020-DM-I(A) dated 17.05.2020 for strict implementation of the guidelines on lockdown measures which will come into effect from 18.05.2020 and will continue upto 31.05.2020;

**Whereas**, it was felt that there was a need to take a cautious approach while implementing the directions of MHA issued vide Order no. 40-3/2020-DM-I(A) dated 17.05.2020 as many migrants had started entering the state of Jharkhand from various states and also other countries severely effected by COVID-19 therefore in exercise of the power conferred under section 22(2) (h) of the Disaster Management Act, 2005 the Chief Secretary, Government of Jharkhand, in his capacity as Chairperson, State Executive Committee, issued directions vide Order no. 620/CS, dated 18.05.2020 as amended by Order no. 658/CS, dated 20.05.2020 to all the Departments of Government of Jharkhand and all the District Administrations for the strict implementation of guidelines issued by Ministry of Home Affairs vide Order no. 40-3/2020-DM-I(A) dated 17.05.2020 for the extended period of national lockdown for a further period upto 31.05.2020 with effect from 18.05.2020 with the following modifications :

- I. Under clause 8 of MHA Order no. 40-3/2020-DM-I(A) dated 17<sup>th</sup> May 2020 only following additional activities were permitted **outside containment zone(s)**.
1. Industrial activities in industrial areas (irrespective of access control).
  2. Construction activities.
  3. Godowns/ Wherehouses.
  4. Shops selling hardware/ construction related items/ all book shops/ stationary shops/ retail outlets of telecom companies.
  5. Service centers of Mobiles, Watches, Consumer electronics like TV, IT related products like computers and consumer electrical

products like refrigerators/ Air conditioners/ Air Coolers etc. in the entire state except municipal corporation areas.

6. Private offices.
8. Retail liquor Shops.


II. Under clause 3 (ii) of MHA Order no. 40-3/2020-DM-I(A) dated 17<sup>th</sup> May 2020 only following additional activity were permitted **outside containment zone(s)**:

1. Intra District and Inter District Movement of taxies on hire.

**Whereas**, it was felt necessary to open up more economic activities in a phased manner and to ease out hardships being faced by the common man;

**Now therefore**, In continuation of Order no. 620/CS dated 18.05.2020 & 658/CS dated 20.05.2020 issued by Department of Home, Prison & Disaster Management (Disaster Management Division), Government of Jharkhand and in exercise of the powers, conferred under Section 22(2)(h) of the Disaster Management Act, 2005 the undersigned, with the approval of Chief Secretary-Cum-Chairperson, State Executive Committee hereby orders to **include** the following to the Order no. 620/CS dated. 18.05.2020 as amended by Order no. 658/CS, dated 20.05.2020 for strict implementation by all the Departments of Government of Jharkhand and all the district administrations :

**Inclusion of Sub-Clause 1(A) under Clause I**  
1(A) Industrial activities in Urban areas.
